**Sub: Guidelines to RAs for following Standard Operating Procedure (SOP) for EODC monitoring of both Advance as well as EPCG authorizations using software in website <http://eodc.online> - Req.**  
**Ref.: Policy Circular No. 16/2015-2020 dated 09.01.2019**

We wish to inform you that Director General of Foreign Trade, New Delhi has developed software for EODC monitoring of Advance as well as EPCG authorizations issued by RAs and RAs in fact have been feeding data in that module for quite some time now. Presently the module has the following facilities:

- i) RAs can enter details of all pending Authorizations where applicant has submitted application for grant of EODC or otherwise.
- ii) Monitor RA-wise, scheme-wise details like number of cases pending or documents not submitted, number of cases where Deficiency Letters have been issued, number of cases where EODCs have been granted, number of cases where SCNs have been issued and number of cases where Orders-in-Original have been passed under adjudication procedure.

EODC.online is designed to help exporters to monitor the status of their applications submitted for grant of Export Obligation Discharge Certificate in respect of Advance Authorisations / EPCG Authorisations, **Exporter can enter authorisation number to ascertain status of EODC** at <http://eodc.online/>
