**Sub: 1) Regarding procedure of validating the Bank Accounts and rectification of EGM errors for smooth availing of IGST Refund through PFMS Portal (Facility notice no.25/2017)**

**2) Regarding validation of bank accounts in the PFMS for speedy and smooth disbursement of IGST export refund (P/N. No. 123/2017)**

This has reference to Customs guidelines for Validating the Bank Accounts and rectification of EGM errors for smooth availing of IGST refund through Public Financial Management System (PFMS) Portal.

- 1) Office of the Commissioner of Customs (Export), Air Cargo Complex, Sahar, Mumbai has issued facility notice no. 25/2017 regarding Procedure of validating the Bank Accounts and rectification of EGM errors for smooth availing of IGST Refund through PFMS Portal.

Some of the gist's of the notice are as given below:-

- It is pertinent to mention here that Bank Account details mentioned in Customs EDI/ ICES shall be the same as mentioned in GSTN. Since the disbursements of IGST Export Refunds are through PFMS, it is mandatory that the Bank Account details in Customs EDI & GSTN should match.
- In order to facilitate easy updating of Bank Account in the Customs EDI System, a Help Desk has been specifically constituted at Drawback (EDI) Section, Air Cargo Complex Sahar, Mumbai. The Exporters/their Authorized Representatives are requested to submit the following documents to the Help Desk for necessary updating their Bank Accounts details in the Customs EDI System.
- Since the Refund of IGST can be withheld on account of various reasons other than non-validation of Bank Accounts, the Exporters are requested to also approach the EGM Co-ordination Help Desk of this Commissionerate for correcting the EGM errors, if any in respect of Shipping Bills pertaining to them.

- 2) Office of Commissioner of Customs NS-IV, JNCH, Nhava Sheva, Tal. Uran has issued Public notice no. 123 dated 28.09.2017 regarding validation of Bank Accounts in the Public Financial Management System (PFMS) for speedy & smooth disbursement of IGST (Integrated Goods & Services Tax) Export refund.

Some of the gist's of the notice are as given below:-

- In order to avail the IGST refund, it is mandatory that the exporters have validated their bank accounts by "Public Financial Management System (PFMS)". If bank accounts of the exporters are closed and/or not validated by PFMS, then the IGST refund, even if sanctioned, may not get credited to the accounts of the exporters.
- As per above PN, it is reported to JNCH that "closed" bank accounts of the exporters still exist in the system and PFMS has invalidated such accounts making the prospective disbursement of IGST refund to such closed accounts impossible.
- The list of list of accounts, which are not validated by PFMS pertaining JNCH(Export) is uploaded on the website of the "Jawahar Lal Nehru Customs House" (<http://www.jawaharcustoms.gov.in>) under the heading "Latest Updates" for wider publicity and necessary action at the end of the concerned exporters.
- In view of the above, exporters are advised to update their bank accounts immediately and not to make any changes in the same during the current financial year for smooth disbursement of IGST refund.
