This is to inform you that vide Trade Notice No: 37/2018-19 dated 02nd November 2018 issued by Jt. DGFT New Delhi which directs all the EPCs to facilitate online submission of Membership Application for issuance of RCMC of new as well as renewal of Membership and its uploading on DGFT server.

Accordingly, from 1st January, 2019, issuance of RCMC to Members will be made through Online mode only. Hence, Members are requested to submit their application for New as well as Renewal of Membership only through Online mode from this date.

Moreover, facility for uploading the scanned copies of supporting documents viz. IEC Certificate, MSME Certificate etc along with the Application form have also been made online. However, Members are requested to compulsorily send the copies of uploaded documents with self-certification to the Council within 7 days of Online submission along with prescribed Membership fees through NEFT / RTGS/ DD / Cheque and furnish the payment details online.

Hence, from 1st January, 2019, Members are requested to visit the Council's website www.plasticsepc.org and click the link "MEMBERS LOGIN" and choose any of the below sub-links and submit their Application Online towards

- New Membership Registration
- Membership Renewal

Above all, as a mandatory requirement, the Council is uploading the individual RCMCs issued online in the DGFT's server. Hence, we request you to kindly ensure that the information furnished in the Application Form is thoroughly checked and validated before submission.
