Sub : Operational problems being faced by EOU in GST regime consequent to amendment in Notification no. 52/2003-Customs dated 31-3-2003- req.

As members are aware that EOUs are allowed duty free import of goods under notification No.52/2003-Custom dated 31-3-2003 (<http://www.cbec.gov.in/htdocs-cbec/customs/cs-act/notifications/notfns-2003/cs-tarr2003/cs52-2k3>). However, in view of GST the said notification has been consequently amended by notification No. 59/2017- Customs dated 30-6-2017 (<http://www.cbec.gov.in/resources/htdocs-cbec/customs/cs-act/notifications/notfns-2017/cs-tarr2017/cs59-2017.pdf>).

Subsequently, issues has been raised by EOU unit regarding B-17 bond, information about estimated quantity and value of goods, inter unit transfer of goods from one EOU to another supported by procurement certificate, in this regard the Directorate General of Export Promotion, Central Board of Excise & Customs has issued a circular Circular No. 29/2017- Customs dated 17th July, 2017 giving clarification on operational problem being faced by EOU.
