As members are aware that Registered Exporter System (REX) was introduced under EU GSP vide PN no 51 dated 30.12.2016. This information was circulated to our member through circular ref. no. Plexh/Cir/1657 dated 05.01.2017 (copy annexed below).

During the period of its operation, request for clarifications have been received from Trade and Industry. Subject : Certification of Origin of Goods for European Union Generalised System of Preferences (EU-GSP) - Modification of the system as of 1 January 2017.

Ref. : Public notice No.51/(2015-2020) dated 30.12.2016

This is in continuation of our earlier circular Ref no. Plexh/Cir/1466 dated 02nd December 2016 regarding Certification of origin of goods for EU Generalised System of Preferences (GSP) with the Registered Exporter System – Concept Note (annexed below).

DGFT New Delhi has issued Public Notice No. 51/(2015-202) dated 30.12.2016 regarding Certification of Origin of Goods for European Union Generalised System of Preferences (EU-GSP) - Modification of the system as of 1 January 2017. The European Union (EU) has introduced a self-certification scheme for certifying the rules of origin under GSP from 1.1.2017 onwards. Under the Registered Exporter System (REX) being introduced from 1.1.2017, exporters with a REX number will be able to self-certify the Statement on Origin of their goods being exported to EU under the GSP Scheme. For more details please refer attached Public notice.
