Subject: Regular Submission of Export Returns of member exporters to the Council

This has reference to regular submission of export returns of member exporters to the council.

While analyzing member's quarterly export returns data we came to know that many of the members have not submitted their online export return for the first quarter of 2015-16. This is really surprising for us that why members are not submitting their export returns.

We hereby brief below to members that 'Why they should submit export returns to the Council's':

-

- Information is required to analyze the export trend and formulate the proper export promotion strategies.
- We need to send regular report to the Ministry of Commerce of our members export performance.
- **Kindly refer para (2.96-b) of Hand Book of Procedure (2015-2020), appended below which stipulates that the submission of regular export return is compulsory**

:-

2.96 (b) Exporter shall furnish quarterly return /details of his exports of different commodities to concerned registering authority. However, status holders shall also send quarterly returns to FIEO in format specified by FIEO.
