SUBJECT: Seeking details of problems faced by members while exporting to Brazil

This is in reference to the communication dated 15.05.2018 received from Department of Commerce (LAC Division) and to our earlier circular Ref: Plexh/Cir/2303 stating that the 5th Meeting of India-Brazil TMM is proposed to be held in New Delhi, India in the month of June 2018.

India-Brazil TMM is an institutional mechanism to identify bottlenecks and to take appropriate measures to overcome operational/ tariff and non-tariff obstacles to bilateral trade between India and Brazil. The last (4th) meeting of TMM was held on 30th September, 2016 in Sao Paulo, Brazil. Therefore, we request you to provide us with details of all problems including bilateral issues (tariff & non-tariff) that you've faced and/or are facing while exporting goods to Brazil. The responses received from you shall be shared with the Department of Commerce (LAC Division) so that they can discuss them with their Brazilian counterparts and seek appropriate solution.
