We are in receipt of communication from Department of Commerce regarding holding of 3rd meeting of India-Argentina Joint Trade Committee (JTC) in New Delhi during October / November, 2018.

India – Argentina Joint Trade Committee (JTC) was established under the Trade Agreement signed between India and Argentina in 1981 with the mandate, among other things, to “analyse and study the implementation of the provisions of the agreement” and “to review measures with a view to solving problems that might arise in the implementation of the Agreement or in the trade exchange between the two countries”. Attached herewith soft copy of trade agreement the trade exchange between the two countries.

Considering the potential of trade between the two countries and impediments coming in way of bilateral trade, the mechanism is being revived by holding of the third meeting in New Delhi. Members are requested to update us on issues to be taken up with Argentina and (ii) issues which Argentina side might raise during the meeting.
