SUBJECT : India-Peru Trade Agreement- Providing of Inputs regarding

This refers to the stakeholder's meeting held under the chairmanship of Shri Shyamal Misra, Joint Secretary on 27.12.2017 on India Peru Trade Agreement. During the meeting, discussions were held on the tariff concessions to be offered to Peru and also tariff concessions to be sought from Peru on each others' respective Wish Lists in chemicals, pharmaceuticals, plastic, rubber, leather and textiles sectors.

Our council has already circulated wish list of 4970 nos. of items at 8 digit code vide circular Ref No. Plexh/Cir/1307 dated 18.09.2017 and matching table vide circular ref.: Plexh/Cir/1787 dated 14.12.2017. Matching table contains Peruvian Tariff Lines and corresponding Indian tariff lines, tariff duties and trade data. Both the list attached herewith again for your reference.

Members are requested to provide their inputs after analysing the various aspects such as trade volume, competitiveness, domestic market requirement on each tariff line where concessions are to be sought from Peru vis-à-vis the concessions to be offered to Peru. Please note that Department of Commerce has emphasised that inputs are required not just on concessions to be sought from Peru, but also where we can give concessions to them. Requisite inputs are to be given as per attached proforma (**Annexure-I and Annexure-II**) only and separate write up on all the regulatory issues and any other issue which impede their exports to Peru latest by 12th January, 2018 at bharti@plexconcil.org.

We request your urgent response in this regard.
