Launch of the India Standards Portal by the Hon'ble Minister for Commerce & Industry, Ms. Nirmala Sitharaman. The portal is a joint initiative of the Department of Commerce and CII. It is operated and managed by CII, and can be accessed at: <a href="www.indiastandardsportal.org">www.indiastandardsportal.org</a>. The portal is a one stop center for all information on Standards, Technical Regulations, conformity assessment & accreditation practices, and the related bodies in India.

Presentation on the ZED Scheme of the Ministry of MSME, by Dr. A.Raj, Senior Adviser, Quality Council of India. The ZED Scheme (Zero Defect, Zero effect on the environment) for the MSME sector, proposes to assess MSME's on various parameters, focusing on quality and environmental performances. It aims to rate and handhold all MSME's to deliver top quality products using clean technology. ZED certified companies are likely to be made a benchmark for suppliers to PSU's and Defence sector, and will serve as a credible recognition for international customers and foreign direct investors seeking investments in India.

The Ministry of MSME has also launched the "Financial support to MSME's in ZED certification scheme" for the benefit of MSME's during the 12th Five Year Plan.
