Sub : Visit of a delegation led by Hon'ble CIM to Cuba and Panama during 30th October- 3rd Nov'2017 to attend FIHAV Event 2017 in Cuba

We have been informed by Department of Commerce, that Hon'ble MoS (I/C) for Commerce & Industry will lead a business delegation to Cuba and Panama during 30th October- 3rd November, 2017. The visit of CIM led delegation will coincide the FIHAV 2017 event being organized in Havana, Cuba.

India is participating in the event with 50 companies under the aegis of ITPO and FIEO.

* FIHAV is a multi-sector trade fair in Cuba and is organized annually in Havana, Cuba since 1983. This is one of the largest trade exhibitions in the region. Last year, over 1000 companies from 70 countries participated in the event. The main sectors of the event are pharmaceuticals, auto components, raw materials, food, textiles, consumer goods, industrial machinery, forestry and wood products, information and communications technologies, infrastructure, live sciences, mining, ocean technologies, oil & gas, professional services, sustainable technologies, tourism, and transportation. * The event is being organized at a time when there is a peak tourism season in Cuba. India is participating in FIHAV event for the first time. Hon'ble CIM would inaugurate the India Pavilion at FIHAV, Havana and also lead a business delegation to Cuba and Panama.

* The purpose of our participation is to enhance our exports as there is immense potential to expand our trade in the CARICOM region. As about 60 countries are participating in the FIHAV event, it is not just a Cuba-centric event and there will be interaction with all the participating countries.
