SUB: SUGGESTIONS FOR PRE - BUDGET PROPOSALS FOR THE YEAR 2018 - 19.

This has reference to communication dated 19.07.2017 received from Ministry of Commerce & Industry.

For the Pre-Budget Exercise for the forthcoming year 2018-19, export - related proposals are invited for consideration by the Department's of Commerce in the prescribed Proforma (copy enclosed).

It may be noted that the budget proposals should be sent in the light of the following: -

- Budget proposals should be complete in all respects, properly categorized and HS Codes for each commodity must be provided.
- Justification given in favour of the proposals shall be restricted to 300 words and annexure should be used, if necessary.
- Issues discussed year after year but never agreed to, may not be raised again.
- Proposal of small reduction/exemption in custom duties, Goods Service Tax etc should be avoided unless they are absolutely necessary if such reduction/exemption are necessary, then ample justification should be given.
- Where temporary relief has been given to some sector for particular period (i.e upto 31st March, 2018), then it should be re-examined and views may be submitted on these as well.

Concrete and relevant Pre-Budget proposals/suggestions with justifications are invited from members. The relevant suggestions will be represented to the Department of Commerce for their further necessary action in the matter.

Kindly forward your proposals/suggestions with justifications in the attached Proforma with all relevant inputs called for, by August 4, 2017 to the undersigned at bharti@plexconcil.org.
