**Sub: Regarding negotiations on proposed Preferential Trade Agreement between India & Iran**

We wish to inform you that India and Iran are engaged in negotiations for entering into Preferential Trade Agreement (PTA). The fourth round of negotiation for the proposed PTA was held on 05-06 March 2019 at Teharan. In this regard our Ministry is seeking inputs on the following issues :-

Products to be identified for concessions to be provided by Indian for Iranian exports to India (HSCode 2017 at 6 & 8 digits)

Quantum of concessions to be provided on the basis of Margin of preference and the period of such reduction (whether in one step or spread over a specified period);

Products to be identified for seeking concessions from Iran for Indian exports to Iran (HSCode 2017 at 6 & 8 digit)

Quantum of concessions to be sought on the basis of Margin of Preference and the period of such reduction (whether in one step or spread over a specified period).

For expeditious conclusion of PTA, products needs to be identified quickly for finalisation of request and offer lists. Members are requested to kindly go through the attached file and suggest which product can be matter of tariff concession under the PTA.
