CERTIFICATE OF ORIGIN

(COs), it is an instrument which establishes evidence on origin of goods imported into any country.

(OR)

It is an important international trade document attesting that goods in a particular export shipment are wholly obtained, produced, manufactured or processed in a particular country.

For availing the Certificate of Origin from us, it is mandatory that, concerned exporter has to register their Company/Firm with 'The Plastics Export Promotion Council (PLEXCONCIL)'.

These certificates are essential for exporters to prove where their goods come from and therefore stake their claim to whatever benefits goods of Indian origin may be eligible for in the country of exports.

Rules of Origin (ROO) are those laws, regulations and administrative determinations of general application to ascertain a products country of origin. They are a set of principles to determine the economic content and nationality of a product.

Two major types of Certificate of origin

- "**Non-Preferential COs**", which certify that the country of origin of a particular product does not qualify for any preferential treatment.
- "**Preferential COs**" refers to COs which enable products to enjoy tariff reduction or exemption when they are exported to countries extending these privileges: e.g. GSP, GSTP, SAARC (SAPTA), APTA, ISLFTA etc.

The main type issued by PLEXCONCIL is **Ordinary/ General Certificate of origin**

Documents to be submitted with the request letter on Company's letter head.

1. Original invoice (two copies) with company seal and signature.
2. Original Packing list (two copies) with company seal and signature.
3. Photocopy of original Bill of Lading / Airway Bill.

Charges: {Rs 200/- per set (as administrative expenses) + 18% GST}. Payment may be made by Cash or *Demand Draft (DD must be drawn in favour of 'The Plastics Export Promotion Council' payable at Mumbai)*. Payment is to be made alongwith submission of above document.

Preferential Certificate of origin

Blank form for Certificate of origin for export under APTA & SAPTA should be collected from Export Inspection Council (EIC). EIC is agency authorized to print blank certificates.

Certificate of origin for export under Asia-Pacific Trade Agreement (APTA)

Documents to be submitted with the request letter on Company's letter head.

1. Filled-in application form in duplicate.
2. One original invoice with company seal and signature.
3. Self-certified copy of Bill of Lading / Airway Bill.
